In construing this document, whenever the context requires, the singular shall include the plural, the plural shall include the singular, the whole shall include any part thereof, any gender shall include the masculine, feminine and neuter gender, and the term "person" shall include any individual, firm, partnership (general or limited), joint venture, corporation, limited liability company, trust, association, or other entity or association or any combination thereof. No presumption or burden of proof shall arise favoring or disfavoring any person by virtue of the authorship of any of the provisions of this document.

If any provision of this document or the application thereof to any person or circumstance shall be invalid or unenforceable to any extent, the remainder of this document and the application of such provision to other persons or circumstances shall not be affected thereby and shall be enforced to the extent permitted by applicable law.
